The regular meeting of the Town Council of the Town of Newton was held on the above date at 7:00 p.m. Present were Mrs. Becker, Mr. Elvidge, Mr. Ricciardo, Mr. Flynn, Mayor Diglio, Thomas S. Russo, Jr., Town Manager, and William Hinkes, Esq., Town Attorney.

# AUTHORIZE THE EXECUTION OF AN AGREEMENT BETWEEN THE TOWN OF NEWTON AND SCARC INC., FOR THE DISBURSEMENT OF FUNDS FROM THE TOWN OF NEWTON'S HOUSING TRUST FUND

WHEREAS, SCARC, Inc. (hereinafter referred to as "SCARC") is a New Jersey 501(c)(3) non-profit corporation that provides supportive housing for people with special needs; and

**WHEREAS**, the Town of Newton adopted a Housing Element and Fair Share Plan on June 16, 2010 that included a variety of mechanisms for providing affordable housing in the Town; and

**WHEREAS**, the Town of Newton adopted a Spending Plan that was approved by the Council on Affordable Housing (COAH); and

**WHEREAS**, SCARC is working with the Town of Newton to construct a new facility for residential use for residents with special needs; and

**WHEREAS**, the project was not part of the Town's Housing Element and Fair Share Plan or Spending Plan but the Town recognizes the project as an emergent affordable housing mechanism that has merit and will be valuable to the Town of Newton; and

WHEREAS, the Town of Newton has received a request for FORTY EIGHT THOUSAND DOLLARS (\$48,000.00) for the use of construction or reconstruction of structures in the Town of Newton for residents with special needs, and the Town of Newton ("Town") has reviewed said request; and

**WHEREAS**, the Town wishes to disburse FORTY EIGHT THOUSAND DOLLARS (\$48,000.00) to SCARC, subject to the terms of a written agreement for the appropriate use of said funds; and

**WHEREAS**, the Town will seek to amend its Spending Plan to provide the funds to SCARC for use on this emergent affordable housing mechanism; and

**WHEREAS**, the Town recognizes that the project meets the COAH's criteria set forth in N.J.A.C. 5:97-6, and the Town of Newton shall submit information regarding the SCARC project in a format to be provided by the COAH so that it may be approved by COAH prior to disbursing the funds; and

**WHEREAS**, the Town of Newton seeks to earmark the requested \$48,000.00 from the Town's Affordable Housing Trust Fund for use by SCARC so that funds may be disbursed to SCARC following all necessary approvals from COAH;

**NOW, THEREFORE BE IT RESOLVED,** by the Town Council of the Town of Newton, that we hereby authorize the Mayor, Town Manager, and/or Municipal Clerk to act as follows:

- 1. Execute a written agreement with SCARC for the administration of affordable housing units in accordance with regulations promulgated by COAH.
- 2. Submit an amendment to the Town's Spending Plan to include the mechanism at the earlier of two years after the Council's approval of the spending plan amendment or the next planned amendment to the Fair Share Plan resulting from plan evaluation review pursuant to N.J.A.C. 5:96-10.
- 3. Submit monitoring pursuant to N.J.A.C. 5:96-11 to COAH relating to the affordable units created using affordable housing trust funds.
- 4. Earmark FORTY EIGHT THOUSAND DOLLARS (\$48,000.00) from the Town of Newton's Housing Trust Fund in accordance with the terms and conditions of the aforementioned written agreement; and
- 5. Following all approvals from COAH and execution of an agreement as outlined in this resolution, disperse FORTY EIGHT THOUSAND DOLLARS (\$48,000.00) from the Town of Newton's Housing Trust Fund in accordance with the terms and conditions of the aforementioned written agreement.
