"Person-to-Person Transfer of Plenary Retail Consumption License No. 1915-33-009-004"

WHEREAS, an application has been filed for a Person-to-Person Transfer of Plenary Retail Consumption License Number 1915-33-009-004, heretofore issued to The Spring Street Pub & Grill, LLC, t/a The Spring Street Pub & Grill LLC for premises located at 144 Spring Street, Newton, New Jersey; and

WHEREAS, Sakel-Grapsas, Inc. has agreed to transfer plenary Liquor License #1915-33-009-004 to The Spring Street Pub & Grill LLC, located at 144 Spring Street, Newton, New Jersey; and

WHEREAS, The Spring Street Pub & Grill LLC has submitted a complete application form for Person-to-Person Transfer of a Class C Plenary Retail Consumption Liquor License bearing the State-assigned license number of 1915-33-009-004; and

WHEREAS, the submitted application form is complete in all respects, and the transfer fees have been paid and the license has been properly renewed for the current license term; and
