a. Louise Wilson - New Jersey Future

Louise Wilson, Green Infrastructure Manager of New Jersey Future, made a Power Point presentation on Mainstreaming Green Infrastructure. The program objective is to improve water quality in New Jersey by making the use of green infrastructure a mainstream practice in growth and redevelopment areas through innovative designs and strong public-private partnership. Mrs. Wilson strongly encouraged the Town to participate in this program and believes Newton could be a leader based on the strong foundation of forward-thinking planning, policies and stewardship.

Nathanial Sajdak, Watershed Director of Sussex County Municipal Utilities Authority, updated the Council on his projects with the Town of Newton. The Town of Newton has the opportunity to become a leader in the watershed areas and truly make a difference, he indicated

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
 - 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated
 - b. Items of appropriation are properly set forth
 - c. An itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality
- 5. The budget and associated amendments (if any) have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
 - 6. That all other applicable statutory requirements have been fulfilled.
