DISCUSSION (WORK SESSION)

Mayor Ricciardo reviewed the legal opinion from Mark Hontz, Esq., Town Attorney, noting that the short answer is that, "the practice of including a recitation of the Lord's Prayer at Newton Town Council Meetings is not permissible because it violates the First Amendment of the United States Constitution." As outlined in the eleven page opinion, there are several options that were provided as an alternative "invocations".

The Council each expressed their disappointment with the "Lord's Prayer" being eliminated after having this "tradition" for the past fifty-six (56) years.

After a lengthy discussion, Mayor Ricciardo directed Mr. Russo to tailor the suggested prayers and submit to the Town Council for their review at the next meeting.

B. 2009 Municipal Budget

Mr. Russo asked if Council was available for the proposed dates to hold two work session meetings to discuss the 2009 Municipal Budget. All members of the Council were available for Saturday, January 31st. and Thursday February 5th. Mrs. Read will publish as required by law.

OPEN TO THE PUBLIC

Mr. Anwar Qarmout, 45 Woodside Avenue, Newton, questioned why the Lord's Prayer is being removed and indicated that he disagrees with the governing body eliminating same.

There being no one else from the public to be heard, Mayor Ricciardo

closed the public portion.

COUNCIL & MANAGER COMMENTS

Councilwoman Le Frois congratulated Mr. Russo being sworn in as a new Commissioner for the Sussex County Sheriff's CrimeStoppers organization.

At this time, upon motion of Mrs. Le Frois, seconded by Mrs. Unhoch and carried, the Town Council went into Executive Session at 8:29 p.m.

Mr. Scott J. Holzhauer, Newton Tax Assessor, updated Council of the 2008 State Tax Appeals for the Town of Newton. After a lengthy discussion, Council thanked Mr. Holzhauer for all his efforts with the tax appeal process.

Mr. Glen Scotland, Esq., Redevelopment Counsel, McManimon and Scotland, and Mrs. Jessica Caldwell, P.P., A.I.C,P, Town Planner, updated

Council on the pending issues surrounding contract negotiations.

Mr. Russo, Mrs. Caldwell, Town Planner, and Mr. Scotland,

Redevelopment Counsel, updated Council on the various options with

regard to the Newton Armory property.

There being no other business in executive session, upon motion of

Mayor Ricciardo, seconded by Mrs. Le Frois, and carried, Council exited

executive session at 10:37 p.m.

Mayor Ricciardo questioned why the huge loss of water allocations

and directed Mrs. Millikin to have a report by the next Council meeting.

There being no one from the public to address the Council, upon

motion of Mrs. Le Frois, seconded by Mrs. Becker and carried, the meeting

was adjourned at 10:48 p.m.
