2020-1
Addendum No. 2**

WHEREAS, as the Newton Emergency Management Coordinator, I, Kenneth Teets, previously declared a Local State of Emergency by way of Proclamation of Local Emergency 2020-1; and

WHEREAS, Addendum No. 1 was issued to add additional information regarding said Proclamation of Local Emergency; and

WHEREAS, I have determined it is necessary, in consultation with Newton Town Manager Thomas S. Russo, Jr., to implement further restrictions in order to protect the health, safety, and welfare of Town employees and volunteers, and members of the general public;

NOW, THEREFORE BE IT ORDERED, that I, Kenneth Teets, Newton Emergency Management Coordinator, do hereby order the following, effective 8:30am, Tuesday, March 17, 2020:


1. All Municipal Buildings are closed to the public for general business. Employees are still expected at work during their regularly scheduled shifts and all municipal business should be conducted via mail, email, telephone, videoconferencing, and/or website.
2. The lobby area of the Newton Police Department remains open for regular business.
3. The Recycling Center will be closed until further notice.
4. All fields, parks, and playgrounds at both Memory Park and Pine Street Park are closed to the general public.
5. The Utility Advisory Board meeting of Tuesday, March 17, 2020 will go on as scheduled.
6. The Planning Board meeting of Wednesday, March 18, 2020 will go on as scheduled.
7. The Town Council meeting of Monday, March 23, 2020 will go on but with a new start time of 6:00pm, not 7:00pm as originally advertised.

These restrictions remain in place until lifted by order of the Town Manager or by the Newton Office of Emergency Management.
