The regular meeting of the Town Council of the Town of Newton was held on the above date at 7:00 p.m. Present were Mrs. Becker, Mr. Elvidge, Deputy Mayor Ricciardo, Mr. Flynn, Mayor Diglio, Thomas S. Russo, Jr., Town Manager and Ursula Leo, Town Attorney. Also in attendance was Mrs. Millikin, Deputy Town Manager, Ms. Babcock, CFO and Mrs. Caldwell, Town Planner.

Mayor Diglio made the following declaration that "in accordance with the Open Public Meetings Act, notice of this public meeting was given to the two newspapers of record and posted on the official bulletin board on December 31, 2012."

Mayor Diglio led the Pledge of Allegiance to the flag and the Clerk called the roll and upon motion of Deputy Mayor Ricciardo, seconded by Mr. Flynn and carried, the minutes of March 25, 2013 Regular meeting and March 25, 2013 Executive meeting were approved. Mayor Diglio and Councilwoman Becker abstained due to their absence.

OPEN TO THE PUBLIC

Mayor Diglio read the following statement:

"At this point in the meeting, the Town Council welcomes comments from any member of the public on any topic. To help facilitate an orderly meeting and to permit the opportunity for anyone who wishes to be heard, speakers are asked to limit their comments to 5 minutes. If reading from a prepared statement, please provide a copy and email a copy to the Clerk's Office after making your comments so it may be properly reflected in the minutes."

Mrs. Karen Harden-Kitchell, addressed the Council with concerns regarding the boarding homes in Newton and offered to assist with the improvements of same. Mr. Russo advised that at the next Council meeting the Council will be discussing an ordinance which will hold the property owners/landlords of boarding homes accountable for violations incurred by their tenants.

There was no one else from the public to be heard.

COUNCIL & MANAGER REPORTS

a. Good Energy

Carolyn Cantrell, Director of Energy Commodities and Philip Carr, Business Development Director of Good Energy made a presentation to the Town Council on the concept of Government Energy Aggregation (GEA). Through the implementation of GEA program community leaders are providing an additional electricity choice for their residents, harnessing bulk purchasing power and competitive market forces to secure the lowest electricity price in a competitively run bid with the best contract

terms and no early termination fees from the most responsible Third Party Suppliers (TPS).

It was noted that there is no obligation to the residents or to the Town of Newton. Mr.

Carr outlined the requirements necessary in order for GEA to work.

After a lengthy discussion, the consensus of the Town Council was to move forward with the Good Energy project. Mr. Russo and Mrs. Leo will work with Good Energy and review all options prior to commitment.

b. North Hudson - Fire Truck

Mr. Russo reviewed correspondence from David Russell, President of Fire & Safety Services. Mr. Russell has requested the use of the Town's Pierce 95" Mid-mount tower apparatus at North Hudson firehouse. North Hudson has viewed Newton's apparatus and would like see how this fire truck will work in their community regarding the reach of their buildings as well as their firehouse. Council agreed to same with stipulations for mutual aid coverage; certificate of insurance; and insurance coverage for full replacement value and rental cost.

c. Newton Fire Department Proclamation

Mr. Russo noted that the following Proclamation was presented to the Newton Fire Department on Saturday, April 6th.

PROCLAMATION

Newton Fire Department

WHEREAS, the Newton Fire Department was established in December 1835, and is currently comprised of a dedicated group of volunteers who sacrifice their time to help those in need; and

WHEREAS, in 2012 under the direction of Chief Mike Teets, the Newton Fire Department responded to 375 calls and performed over 40 training drills, expending over 4,200 man hours while operating 3 Engines, 1 Ladder Truck, 1 Rescue, and 1 Brush Truck; and

WHEREAS, the caring and loyalty of these dedicated volunteers has been evident throughout the years and continues to serve as a sense of comfort and security to the Town's residents and businesses. The Newton Fire Department also works closely with the Newton First Aid & Rescue Squad, Newton Police Department, Newton Office of Emergency Management, Newton Water and Sewer Utility, and Newton Department of Public Works, as well as providing mutual aid to neighboring municipalities; and

WHEREAS, the Newton Fire Department assists in any kind of emergency, day or night; in 2012 they assisted over 45 families and businesses, expending 200 man hours, during Superstorm Sandy;

NOW, THEREFORE, WE, the Mayor and Town Council of the Town of Newton, hereby proclaim our gratitude and appreciation to the Newton Fire Department for their endless hours of support and service to the Town of Newton and its residents and businesses and thank each and every one of their members for their dedication and service.

d. Newton Fire Department Steak Bust

Mr. Russo announced that the Newton Fire Department will hold their annual Steak Bust on Saturday, April 27, 2013 at the #1 Firehouse from 4:00 p.m. to 7:00 p.m. With no objection from the Council, Mr. Russo will forward a letter of approval with the standard stipulations as discussed.

e. Diller Avenue

Mr. Russo addressed the correspondence from our Town Engineer regarding the speed limit on Diller Avenue. After a brief discussion, Council agreed to have Mr. Russo and Mrs. Leo further pursue additional options regarding the speed limit.

f. School Budget

Ms. Babcock disseminated a letter of response from Donna Snyder, Business Administrator for the Newton Board of Education, regarding the school budget tax increase by the Newton Board of Education.

Deputy Mayor Ricciardo expressed his disappointment with the increase and directed all residents with concerns of the school tax increase to contact the Newton Board of Education located at 57 Trinity Street, Newton.

g. Municipal Clerk Update

Mr. Russo noted that the Municipal Clerk provided a memo requesting an additional item (raffle application) be added to the agenda this evening. It was noted that the agenda will be amended to reflect the added item.

 - f. Any inclusions of amounts required for school purposes
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
 - 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated
 - b. Items of appropriation are properly set forth
 - c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality
- 5. The budget and associated amendments (if any) have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
 - 6. That all other applicable statutory requirements have been fulfilled.

HEARING ON THE 2013 BUDGET

a. 2013 Municipal and Water & Sewer Utility Budget

Mayor Diglio

Mr. Russo made a power point presentation on the 2013 Municipal Budget and Water & Sewer Utility Budget, while focusing on three (3) core areas: (1) cost effectiveness; (2) protecting core services and (3) revenue enhancement. Ultimately, all three (3) core principles are inexorably tied to the prevailing ideology of enhancing mission achievement – making the Newton municipal organization the best it can be.

Mr. Russo noted that the property tax is divided among the County of Sussex, County Library, County Health Department, County Open Space, Newton Board of Education and the Town of Newton. The percentage for each of the jurisdictions received in 2012 from the average taxpayer in the Town is as follows:

Mr. Russo reviewed the 2013 Municipal Budget and Capital Improvements Program which totaled \$11,600.000. The Municipal government is a service-based organization. Approximately 65% of the municipal budget provides funding for the salaries and benefits of 63 full-time and 52 part-time employees, a net decrease of eight (8) employees from 2009.

Mr. Russo reviewed the tax rate for 2013 noting that with State Aid and grant funding continuing to diminish, coupled with the reality of a tax base that is over 35% exempt, it is an ever increasing challenge to maintain appropriate service levels and sound fiscal policies while mitigating any significant municipal tax increases.

The Town experienced a decrease in the Net Valuation Taxable (NVT) in the amount of \$3,596,080, down to \$687,090,410. This caused the average residential structure in Newton to slightly decrease in value from \$222,090 to \$221,256. However, with prudent, conservative budgeting, the Town's 2013 Budget shows a nominal overall

increase of just \$51,207 in the amount to be raised for support of the municipal organization.

Therefore, the Municipal Tax necessary to support the Newton municipal organization, including the Reserve for Uncollected Taxes, is increasing for the 2013 year. The 2013 municipal tax rate will be 1.1514 vs. 1.1380 from 2012, or an increase of 1.34 tax points. The impact on the average assessed residential structure (\$221,256) is only \$20.00 per year or 5 ½ cents per day.

Mr. Russo thanked all department heads, staff and especially Dawn Babcock, CFO for their invaluable assistance in putting together these important documents. In closing, it is my belief that the budget appropriations and revenue projections, as contained in the 2013 budget for Newton, will enable the Town to meet the public's demand and need for critical services. Furthermore, the budget is structured as a fiscally responsible document to ensure that the financial well-being of our municipal government is preserved.

This 2013 budget as presented will enable the municipal organization to continue mission achievement - achieving the excellence in governance expected by our customers: the taxpayers, businesses, and residents of Newton.
