The regular meeting of the Town Council of the Town of Newton was held on the above date at 7:00 pm. Present were Mr. Dickson, Mrs. Diglio, Deputy Mayor Flynn, Mr. Schlaffer, Mayor Le Frois and Thomas S. Russo, Jr., Town Manager. Ursula Leo, Esq., Town Attorney was also present.

Mayor Le Frois made the following declaration "in accordance with the Open Public Meetings Act, notice of this Regular meeting was given to the two newspapers of record and posted on the official bulletin board on January 4, 2019."

Mayor Le Frois led the Pledge of Allegiance to the flag and the Deputy Municipal Clerk called the roll. Upon motion of Mr. Dickson seconded by Mrs. Diglio and unanimously carried, the minutes for the July 22, 2019 Regular meeting were unanimously approved.

OPEN TO THE PUBLIC

At this time, Mayor Le Frois read the following statement:

"At this point in the meeting, the Town Council welcomes comments from any member of the public on any topic. To help facilitate an orderly meeting and to permit the opportunity for anyone who wishes to be heard, speakers are asked to take one turn at the microphone and please limit their comments to 5 minutes. The Deputy Municipal Clerk will keep time. If reading from a prepared statement, please provide a copy and email a copy to the Clerk's Office after making your comments so it may be properly reflected in the minutes."

Tracy Papparella, 56 Halsted Street, thanked the Council for last meeting's discussion on the pool. She hoped in the future there can be an ability to record a meeting in Mr. Russo's absence. She went on to say she did not want to delay the process, but questioned if the two resolutions regarding the pool on tonight's agenda could be pulled from the consent agenda.

John McGuigan, 10 Emmons Avenue, asked if the need for the study was recommended by the engineer, if so when and why? He asked the Council to please consider the impact of this additional study on the goal of the Newton residents to open the pool next year. It appears to him, that goal might be in jeopardy.

Maureen Snellen, Plainfield Avenue, stated she brought up several issues with the pool at the last meeting and she went to the pool the next morning at 9:00am and they were all addressed. She thanked the Council for having them taken care of.

Karen Hardin-Kitchell, resident of Lafayette Twsp., grew up in Newton. She wanted to start off with praise stating the Town-Wide garage sale was amazing. She went on to say at last meeting every Council member stated their desire to reopen the

pool. She asked Mr. Russo if he is willing to do everything possible to reopen the pool.

There being no one from the public to be heard, Mayor Le Frois closed the meeting to the public.

VIII. COUNCIL & MANAGER REPORTS

a. <u>Mayor Le Frois</u> – Mayor Le Frois offered her thanks and appreciation to Councilwoman Diglio for recently attending the staff barbeque. It was a beautiful day and she received a lot of great feedback. Later that day, she and Mr. Russo attended a meeting with potential developers for the G & H property. That night she and Councilwoman Diglio attended "Movie Night" at Memory Park. It was well attended and a great night for everyone. Mayor Le Frois offered her thanks to the Recreation and Community Development Departments for the continued summer activities. The next Movie Night will be August 9th.

On July 26th, she attended a forum held at Newton High School on bringing high speed internet service to Sussex County. Great conversations were had; unfortunately, no one from CenturyLink was in attendance. Lack of high speed internet service puts our community and students at a disadvantage. Many spoke of living remote in areas and do not even have cable service. Mayor Le Frois thanked Newton High School, Mr. Hoffmann, Thorlabs and others for making this forum happen.

Lastly, this weekend's Town-Wide Garage Sale and merchants Sidewalk Sale was a success, she thanked all that participated.

- **b. Deputy Mayor Flynn** No comments at this time.
- c. <u>Councilwoman Diglio</u> She thanked Mayor Le Frois for mentioning the staff barbeque and Movie Night. She recently attended a CLEAR meeting. It will be celebrating its third year soon. It is a great program, progress is amazing and she is happy the program is now county-wide.
- d. <u>Councilman Schlaffer</u> Mr. Schlaffer read the following statement aloud

"In recent weeks it has been brought to light that religiously discriminatory and sexist content was shared to thousands of local citizens through a twitter account operated by a member of the S.C.C.C. board of trustees. Last year we stood on the County College campus and denounced anti-Semitic attacks and made a resolution that stated:

"The Town of Newton, the County Seat, is proud of Newton's racial, cultural and ethnic diversity and the fact the Town is home to residents of different ancestry."

Today we must make that same stand and denounce these actions, as a leader in our community Mr. Scanlan should be capable of better

judgement and lead with better examples. As a representative of a diverse institute of higher learning, he should have known better. He should have done better. Leaders must unify, not divide, and today I want all our fellow citizens to know that the Newton Council stands for unity. We stand for equality and we stand for morality.

The resolution denouncing hate we made last year stated that we:

"categorically condemn such heinous attacks on any of the Town's ethnic groups as well as those around Sussex County."

Today we must make that same stand, hate has no home here, and we will not let hateful rhetoric divide us.

When one of our community leaders calls for the eradication of any group, and in this case, based on their religion. We cannot allow such conduct to go unnoticed, the council must, once again, move a resolution to condemn hatred and intolerance."

Councilman Dickson – He attended the Board of Education meeting on the 23rd. A flooding situation was quickly detected at Halsted but despite it being detected early, damage still occurred including a smartboard, computer, books, carpet, etc. The source ended up being a clogged drain. An insurance claim will be filed for all the damage. During Dr Greene's report, he gave a brief rundown of students plans post-graduation: 8 entered the military, 87% post-secondary education, with % enrolling in 4 year colleges, and 45 students will be attending county college. The food service contract will be awarded to Sodexo with no rate increase. The West End Ave property and the potential future use were discussed. The four potential uses that are being considered are an athletic practice field, tennis and basketball courts, maintenance building, and bus parking.

The athletic field would be a grass field that could accommodate soccer, lacrosse, field hockey, football, etc. This would reduce the need for off-site practices and costs associated with transportation and trainer availability. The tennis and basketball courts being relocated would allow the existing courts to be re-purposed for student, faculty, visitor, and/or bus parking. A maintenance building would allow for the potential space at the high school be re purposed.

Bus parking is an emerging issue on the HS campus and moving it would solve that problem whether it is to the West End property or Merriam Avenue School off of Gardner

After discussion, the Board decided it would be best to reach out to the engineering firm that has already been involved in this property, and find out the costs associated to further study it. This is not a project for the coming year.

On July 21st, he attended the "Purple Party" at Maxwell and Molly's on Spring St. It was in celebration of the stores 12th anniversary, and their 5th consecutive Reader's Choice Gold Award. Rick and Bonnie Bitondo are wonderful people and great business owners that really care about not only their customers but Spring Street and the Town of Newton, so congratulations to them.

e. <u>Town Manager Russo</u> - Mr. Russo said he had a few comments and would address the pool later in the meeting when he gives an update from Suburban. He then stated the Town will be applying for a Community Development Block Grant.

Mayor Le Frois stated to approve submittal of this grant application there will be a brief but Special Town Council meeting on Monday, August 26, 2019 at 6:00pm. It will be advertised as well.

Mr. Russo continued, stating offices will be closed for Labor Day. The Taste of Newton being held on September 9th, the next regular Town Council meeting will be on September 11th.

Mr. Russo offered his congratulation to Dawn Babcock on her pending retirement on November 1st. There is a resolution on the agenda for this evening. He stated it has been a pleasure working with Dawn all these years. She has been both an asset to the Town and her chosen field of profession. She will be missed and he wished her well.

Mayor Le Frois on behalf of the entire Town Council offered her congratulations to Dawn, and thanked her for her many years of service. She is always very thorough, knowledgeable, and organized. She is always ready to answer questions and our auditors and other professionals have stated they enjoyed working with you. She wished her luck on her retirement and future endeavors.

ORDINANCES

Mayor Le Frois directed the Clerk to read aloud the following Ordinance relative to final adoption.

ORDINANCE #2019-7

AN ORDINANCE REVISING ARTICLE I OF CHAPTER 57, ANIMALS AND CHAPTER 320, ZONING OF THE CODE OF THE TOWN OF NEWTON REGARDING ANIMALS

WHEREAS, the Newton Town Council has reviewed the Town Code regarding animals permitted within the Town and has determined that revisions are necessary;

NOW, THEREFORE BE IT ORDAINED, that Article I of Chapter 57, Animals, shall be revised and Section 320-28. J shall be revised to reflect the desired changes.

SECTION 1:

Chapter 57, Article I, Keeping and Housing of Animals and Fowl, shall be deleted and its entirety and shall be replaced as follows:

ARTICLE I. DOMESTIC ANIMALS

§57-1 DEFINITIONS

Animals Running at Large

"At large" shall mean off the premises of the owner or custodian of the animal, and not under the immediate control of the owner or custodian

Domestic Animals

Any animal that has been bred and/or raised to live in or about the habitation of humans and is dependent on people for food and shelter, and not raised for commercial gain; including among others dogs, cats, guinea pigs, reptiles, chickens and fish; and excluding: poisonous and dangerous animals such as lions and bears, livestock such as horses and cows, and other animals weighing more than 100 pounds.

§57-2 DOMESTIC ANIMALS

Domestic animals shall be permitted within all Zones within the Town of Newton.

§57-3 ANIMALS RUNNING AT LARGE

No person shall permit any animal regularly housed on his property or in his possession to run at large, nor shall any animals be permitted upon the streets or other public ways of the Town unless under the immediate control of the owner or his authorized custodian. Such action is declared to be a nuisance and dangerous to the public health and safety.

§57-4 STANDARDS FOR KEEPING CHICKENS

The keeping of chickens in the Town of Newton, other than for farm and agricultural uses permitted per Code Section 320-28.J, shall be subject to the following requirements:

- A. A maximum of five (5) female chickens shall be permitted on any lot.
- B. The keeping of roosters (mature male chickens) and cockerels (young male chickens) is prohibited.
- C. Chickens shall be provided with a fully-enclosed shelter (coop) and a run or fenced enclosure, with the following requirements:
 - 1. Shelters and runs or fenced enclosures are permitted in the rear yard only;
 - 2. Shelters and runs or fenced enclosures shall be located a minimum of five (5') feet from a fenced in property line, and ten (10') feet from any non-fenced in property line and a minimum of twenty-five (25') feet from any residential dwelling;
 - 3. Only one shelter shall be permitted on any lot, with a maximum permitted area of any shelter of 100 SF, and the total area of shelters and attached run shall be a maximum of 150 SF;
 - 4. Shelters/coops shall not exceed six (6') feet in height; and
- D. The shelter and enclosures shall remain in good repair and in a clean and healthy condition, free from accumulation of waste, free from noxious or offensive odor, and free from any condition which may breed flies or other insects. Slaughtering chickens in public view is prohibited.
- E. Storage of manure, waste and odor or dust producing substances shall be kept in a water-tight container, disposed of in accordance with health code and accepted agricultural practices; and such manure and waste storage shall be located at least ten (10') feet from any lot line and a minimum of twenty-five (25') feet from any residential dwelling.

SECTION 2:

Section 320-28.J(2) shall be deleted in its entirety and replaced as follows:

(2) All animals shall be provided shelter for containment, and premises are to be maintained in such a way as to regularly remove waste and prevent odor and attraction of rodents and insects. No building or structure used for shelter or enclosure of fowl, game, horses, or farm livestock shall be closer to any property line than 200 feet.

SECTION 3

Section 320-28.J(4) shall be deleted in its entirety and replaced as follows:

(4) One horse for the personal use of the occupants of the residence may be maintained on any lot at least three acres in size.

SECTION 4: SEVERABILITY AND REPEALER

Should any part or provision of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the Ordinance as a whole or any part thereof other than the part held invalid.

SECTION 5: NOTICE

The Town Clerk is directed to give notice at least ten days prior to the hearing on the adoption of this Ordinance to the County Planning Board and to all others entitled pursuant to the provisions of N.J.S.A. 40:55D-15. Upon the adoption of this Ordinance, after public hearing, the Town Clerk is further directed to publish notice of the passage and to file a copy of this Ordinance, as finally adopted, with the Sussex County Planning Board, as required by N.J.S.A. 40:55D-16.

SECTION 6: EFFECTIVE DATE

This Ordinance shall take effect immediately upon adoption and publication in accordance with law.

By a motion made by Deputy Mayor Flynn and seconded by Mrs. Diglio, Mayor Le Frois opened the meeting to the public.

There being no one from the public to be heard, upon motion of Deputy Mayor Flynn, seconded by Mrs. Diglio and unanimously carried, the hearing was closed.

WHEREAS, the New Jersey Local Publics Contract Law at N.J.S.A. 40A:11-13.2(e) allow for a rejection bids when the purposes or provisions or both of P.L.1971, c.198 (C.40A:11-1 et seq.) are being violated; and

WHEREAS, Longo Electrical-Mechanical Inc., does not fully comply with the New Jersey Local Publics Contract Law at N.J.S.A. 40A:11-27(33) as not meeting the definition of a responsible bidder; and

WHEREAS, Longo Electrical-Mechanical Inc., does not fully comply with the New Jersey Local Publics Contract Law at N.J.S.A. 40A:11-4(a) which demands the lowest bidder deemed responsive and responsible be awarded a bid contract;

NOW, THEREFORE BE IT RESOLVED, by the Town Council of the Town of Newton, Sussex County, that the recommendation of Newton's Qualified Purchasing Agent and Town Engineer is hereby accepted, and the bid response by Longo Mechanical Inc., is hereby rejected under N.J.S.A. 40A:11-13.2(e).

OPEN TO THE PUBLIC

Mayor Le Frois opened the meeting to the public.

Karen Hardin-Kitchell, stated the pool is a special place and so many people are willing to do so much to keep the pool open. Kids in this Town need something to do and pool is that something. Again, she asked Mr. Russo if he is willing to do anything to save the pool.

Tracy Papparella, stated she hoped the Council would address our questions about the pool before the second chance at the microphone. The pool sat empty until the week of July 10th, why was the pool cleaned and then filled. She found an explanation on Facebook from Deb Danielson where she stated they are still doing all the testing, it's ongoing. They didn't have permission to fill the pool because the engineers were still doing testing inside and around the pool. They are doing a very thorough job to ensure the results are accurate. Ms. Papparella understood Ms. Danielson's explanation as meaning the Town was waiting for the engineers to give permission to fill the pool, and when we started to fill the pool we had permission from the engineers.

Megan Hessel, Sparta resident came forth with her three children, Barron, Liesel, and an unnamed child to state they have learned so much on the Newton Swim Team and how much they love the Newton Pool. It's a family favorite.

Jessica Brennan, 124 Elm Avenue, Andover Twsp., stated she relied on public pools growing up in Newark, NJ to stay off the streets. She married a country boy and moved to the area. Her husband grew up in Newton and spent his summers at the Newton pool. The Swim Team is now a big part of their lives. The pool is a gem that brings surrounding towns together. She asked if the Council could share more information on what they know.

Tammie Westra, 3 Grand Avenue, Newton stated she grew up at the pool, she learned how to swim there. Her kids learned how to swim there and then taught kids how to swim being lifeguards. She was president of the Swim Team, her daughter worked at the pool all through college. As a business owner in Town she feels we need to offer more to our kids. The pool was so important to her family. She just wants to know the Town Council is listening and that you hear us.

Meredith Walling, 100 Ryerson Avenue. Ms. Walling said her daughter is a swimmer. It will fail this Town if the pool isn't reopened. She doesn't want to see her property values go down. She has a backyard pool but still used the Newton Pool. She doesn't know what the draw would be to stay in Newton if the pool is not reopened.

Michael Malone, 59 Trinity Street. Mr. Malone stated lots of questions were asked tonight and he would like to know when we will get answers. The pool condition is not new; it has been going on for years, why did it take so long to do something about it. We are entitled to answers. Mr. Malone asked Mr. Russo why he waited so long to do something.

Andrea Carlson, 4 Elm Street. Ms. Carlson is a coach for the Swim Team; she is a former lifeguard at the Newton Pool. Being a lifeguard meant she got to see everyone that came to the pool and not everyone was from Newton. The pool means a lot to many people not just those in this Town. Issues have been going on for several years so why weren't they addressed then?

Evelyn McCord, 70 High Street. Her four children learned to swim at the pool. They went on to become lifeguards to make money to pay for college. Her husband was vice-president for the Swim Team for six years. He swam at the pool long after her

kids grew up. There have been problems there for years and repairs were needed. Why did the Town spend money on making things look nice for people to come but didn't focus on the pool? None of you have given answers to the questions asked.

Mary Rapuano, 18 Hillside Avenue. Her kids used the pool to learn how to swim, she hosted Fresh Air Kids and they learned to swim at the pool. She taught at Vo-Tech and they let their repairs go until the pool had to be closed. It would be a disgrace for the pool to close.

Angelo DePalma, 18 Hillside Avenue. Mr. DePalma stated he cannot think of one other community service on the same level as the pool.

Sara Holbod, 21 Sussex Street. Ms. Holbod stated she recently moved here. She has a small child she hoped to have taken swim lessons at the pool next year. She questioned if anyone has asked the businesses in Town to help.

Courtney Pipher, 98 Ryerson Avenue. She is a third generation Newton resident. She wants her daughter to want grow up and live here but there doesn't seem to be anything here in Newton for her. She also stated she thinks there should have been more of a discussion on the resolutions.

There being no one else from the public to be heard, Mayor Le Frois thanked everyone for coming out and their heartfelt stories and then closed the meeting to the public.

COUNCIL & MANAGER COMMENTS

Mayor Le Frois directed Mr. Russo to give a synopsis of the progress on the pool.

Mr. Russo stated he appreciates the comments and passion of everyone and recognizes the intrinsic value of the pool. When he raised the concerns with the pool with the Council at budget time his concern was the "patchwork quilt" approach and "Band-Aids" we have in the past were not sustainable for the long term. We could have continued to do that, it would be the easy thing, but it wouldn't be the right thing. The right thing to do is raise the concerns with the Council, bring in experts, to analyze, to discuss, and then ultimately for the five people on the Council to make the decision. His job as the Manager is to provide facts, data, information, and analysis. Ultimately, he serves at the pleasure of the Council, so ultimately they will determine the future of the pool, not staff, not the public, not the Town Manager. The decision is made by the five members elected to serve. Your comments have been duly noted.

He went on to say we hired Suburban Engineers and SESI to analyze the pool. He will read into record an update from Suburban. The process will not be delayed with the two resolutions on tonight's agenda. The process is on track with a presentation scheduled for the September 11th at 7:00pm. Mr. Russo urged everyone to mark their calendars. The presentation will include more detail than what he will read tonight, it will include pictures and most importantly two or three options for the Council to weigh in on that evening and give direction that evening. This will allow him to move forward to write bid specs and put things together so the pool can open in 2020. That has always been the goal. This will not be a cheap or easy fix. Mr. Russo stated his commitment is to follow the direction of the Council. They make the decision; he and his staff then work to make it happen. He takes spending tax dollars very seriously; it is not always easy to manage an 18 million dollar budget with a third of the properties exempt. The pool is an asset and amenity and most likely will require a pretty significant financial investment.

Mr. Russo read the following email into the record dated Friday, August 2nd, 2:06pm from John Chayko, of Suburban Consulting.

Hi Tom & Terri,

As a follow up to our recently submitted proposal regarding additional structural analysis (concrete coring), the following is a brief synopsis of SCE's activities to date concerning our assessment of the Community Pool:

- February 28, 2019: SCE's contract to assess the condition of the pool is executed with the Town. This assessment is to be conducted while the pool was officially closed to the public for the 2019 summer season.
- SCE's initial investigation process included available data collection. The 2005 renovation plans of the pool were obtained from the Town. Original construction plans of the pool were not available, however it is our understanding that the pool was built in the late 1950's (60 + yrs. old). In addition, we were informed that the current plastering of the pool was performed in 2014 with subsequent periodic maintenance repairs performed.
- March 2019: Initial site walkthrough requests pool dewatering from DPW to perform survey and inspection tasks. Extensive cracking and delamination at pool bottom visible upon dewatering. SCE recommends subsurface geotechnical testing and analysis to support assessment inspection, which the Town then contracts directly with SESI Consulting Engineers.
- April 3, 2019: LiDAR scan field survey of the pool performed by SCE in advance of inspection task efforts.
- April 15, 2019: Formal site inspection performed by Atlantic Aquatic Engineering, Inc. (SCE's subconsultant).
- May 31, 2019: Coordination with Town DPW & SESI to obtain access and perform geotechnical efforts. Soil borings (3) and groundwater inspection port were performed by SESI. Laboratory analysis of boring samples performed upon completion.
- June/July 2019: Review of geotechnical report and inspection findings both support additional testing measures of the concrete shell to confirm structural integrity. This testing and analysis was not initially included as part of SCE or SESI's

original scope of work efforts in attempts to minimize level of investigative costs if determined unnecessary. It has since been recommended that additional testing be taken to help determine if structural deficiencies in the concrete are the direct cause of current cracking/delamination issues. Proposals from SESI and SCE have been coordinated and submitted to the Town identifying the minimal level of effort necessary to perform this structural analysis.

- August 2019: Upon Town resolution award of additional services, SESI to perform concrete coring (4 min.) and lab analysis testing to determine compressive strength and adherence capabilities. Ground penetrating radar services (GPR) will be performed as part of this task in preparation of the coring to coordinate locations that minimize impacts to any steel rebar reinforcement. SCE to review structural analysis findings and coordinate with final pool assessment recommendations.
- September 2019: SCE to include concrete structural analysis in final assessment report and present these findings and recommendations to the Town Council.

Mr. Russo, concluded the meeting will take place on Wednesday, September 11th. He went on further to state back in July he and the Deputy Mayor attended a meeting with Suburban to discuss their findings. It was at that meeting Suburban strongly suggested if we were going to possibly replaster the whole facility, which could cost \$200,000 to \$500,000 then we should really test the concrete to make sure the structural integrity is there for the concrete to handle the new plaster. Deputy Mayor and I along with staff thought that made sense. They submitted an initial proposal, but the cost was too high. He negotiated with them to get better pricing and for Suburban to lower their fees to try and minimize the costs. There is no delay on the process; the goal is give the Council enough information so they can make a reasoned and informed decision on September 11th.

Mayor Le Frois thanked Mr. Russo for the update. She went on to say the Council appreciates everyone's comments. The Council takes diligent notes, read the minutes, and watch the video recordings. We care very much and take your comments seriously. Some asked why wasn't this address in September when the pool closed. She didn't want to go into a lengthy discussion on municipal finance however repairs could not be done under the 2018 appropriation budget. Municipal budget have rules and guidelines. She is hopeful there will be a full house at the September 11th meeting so everyone gets first-hand information.

Mr. Flynn stated there is no doubt how important the pool is to the residents. He wanted to reiterate there is no intention to close the pool, but to provide the greatest product possible and get the greatest use of tax dollars to make that happen. The purpose of the public comment is meant to hear you; it never works to go back and forth. We wait for everyone to speak and then address your comments at that time.

August 5, 2019

We are all approachable and are here to serve. It is very important to test the integrity

to come to a solution. He understands it is a community asset. He looks forward to

seeing everyone on the 11th.

Councilwoman Diglio stated she had no further comment, Mayor Le Frois and

Deputy Mayor Flynn spoke very well.

Councilman Schlaffer stated the pool has not been in pristine condition in years.

We are cautiously addressing this issue unlike any Council has before. Before we can

have fundraisers we need to know what exactly we are raising funds for. We must all

exercise patience. No one up here wants to lose the last standing community pool in

this county, but there is a reason all other community pools have closed or sold to

private entities. We are doing everything within our power to ensure the Newton Town

Pool reopens and stays a Town amenity. Many members of the Council have young

children we would like to see utilize the pool.

Councilman Dickson stated his fellow Councilmembers summed up everything

well and thanked everyone for their comments.

EXECUTIVE SESSION

Upon motion of Deputy Mayor Flynn, seconded by Mrs. Diglio and unanimously

carried, Council entered Executive Session at 8:24 pm.

Council left Executive Session at 9:12 pm.

There being no further business to be conducted, upon motion of Mrs. Diglio,

seconded by Mr. Dickson and unanimously carried, the meeting was adjourned at 9:13
