The regular meeting of the Town Council of the Town of Newton was held on the above date at 7:00 p.m. Present were Mrs. Becker, Mr. Elvidge, Mr. Ricciardo, Deputy Mayor Diglio, Mayor Le Frois, Mr. Thomas S. Russo, Jr., Town Manager and Mark Hontz, Esq., Town Attorney.

Mayor Le Frois made the following declaration that "in accordance with the Open Public Meetings Act, notice of this public meeting was given to the two newspapers of record and posted on the official bulletin board on December 31, 2010."

Mayor Le Frois led the Pledge of Allegiance to the flag. The Deputy Clerk called the roll and upon motion of Mrs. Becker, seconded by Mr. Ricciardo, the minutes of August 22, 2011(Regular) meeting were approved.

OPEN TO THE PUBLIC

Mayor Le Frois read the following statement:

"At this point in the meeting, the Town Council welcomes comments from any member of the public on any topic. To help facilitate an orderly meeting and to permit the opportunity for anyone who wishes to be heard, speakers are asked to limit their comments to 5 minutes. If reading from a prepared statement, please provide a copy and email a copy to the Clerk's Office after making your comments so it may be properly reflected in the minutes."

Mr. Louis Ratti, 26 Stillwater Road, spoke on his behalf regarding his pending application to the Newton Fire Department. Mr. Ratti indicated Town Manager, Mr. Russo, was in receipt of correspondence from the Fredon Township Fire Chief and President, and challenges the content of the letter as it is misleading. Mr. Ratti advised he is an exempt member of the Newton Fire Department and served on the Newton Volunteer First Aid and Rescue Squad with honesty and integrity. Mr. Ratti thanked the Council for their time.

COUNCIL & MANAGER REPORTS

Mr. Russo indicated that a copy of the North Jersey Municipal Employee Benefits Fund Plan Document was included in the Council packets and if there are any questions or comments, please contact him off line.

Mr. Russo advised he received a fax dated September 12, 2011 from Karen Crossley, a resident of Newton, advising of a motorcycle run and barbeque

fundraiser for a local Town resident to be held on Sunday, September 18, 2011 at the Newton VFW, 33 Mill Street, Newton. Mr. Russo indicated that registration will begin at 10 a.m., the motorcycle run at 11:30 a.m., and the Barbeque will begin at 1:00 p.m. Mr. Russo addressed several concerns and advised he was looking for guidance from the Governing Body.

Mr. Russo read Ms. Crossley's fax aloud at the request of the Governing Body:

Hello,

"On September 18, 2011, we are having a fundraiser for a local town family and will be having a bike run as part of it. (see attached flyer).

There should be approximately 50-100 bikes – mostly family members and local people.

We will be leaving Newton VFW at 11:30am and should be returning 12:30pm.

Start @ VFW and travel north on 519 to Augusta Hill Road to 206. Turning left on 206 North and bearing right on Broad St. in Branchville. Thru town and make a right on Wantage Ave. (519) and proceed all the way to Rt. 23. Turn on 23 South to Rt. 565 (Sussex Inn) Turn right on Rt. 565 to Rt. 206. Turn left on 206 South to Rt. 94 traffic light (Quick Chek) in Lafayette. Turn right and continue thru Germany Flatts to Newton-Sparta Road. Turn right on Newton-Sparta Road and come straight through the center of town going to Mill Street, turning left on Mill Street and returning to the VFW. The ride is about 43 miles.

If there is anything we need to do, please let us know so we can make sure everything is done correctly."

After a lengthy discussion, the Governing Body had no issue with the request as the Town would not be providing road closures, police, or public works assistance.

Mr. Russo advised of a distribution error by the United States Postal Service

which affected the delivery of the Utility Bills. The Utility bills were mailed out on August 31st and delivered to only half the residents in Newton. Mr. Russo indicated as per State Statute, proper payment is due on September 30, 2011. Mr. Russo stated that an alert was placed on the Town website and is looking to do a reverse 9-1-1.

DISCUSSION

a. NJMEBF - Dave Vozza, The Vozza Agency

Mr. Russo introduced Mr. Dave Vozza from the Vozza Agency who will provide Council with updates regarding the Town's Health Insurance Fund.

Mr. Vozza gave a brief overview regarding the structure of the North Jersey Municipal Employee Benefits Fund. Mr. Vozza introduced the new Health and Wellness program which was instituted earlier this year as well as the new billing system which will be implemented in November and allow for on line enrollment.

Mr. Vozza then highlighted Chapter 78, P.L. 2011, the Pension and Health

Benefits Reform bill which was passed on June 28-2011. Mr. Vozza explained the Bill requires employees to contribute to their health care benefits which is based on salary and be phased in over the next four years. Mr. Vozza then explained and outlined several cost effective plan options that can be made available to Town employees. Mr. Vozza also presented a brief overview of the Fund financials. After a brief discussion, the Governing Body thanked Mr. Vozza for his presentation.

b. Chapter 17 - Tree Ordinance

Mr. Russo indicated the next item for discussion was a draft Ordinance amending Chapter 17, Trees and Shrubs, which is based on issues that arose during the recent Hurricane.

Mark Hontz, Esq. explained the verbiage in the existing Ordinance that slowed down the process for rectifying the removal of any tree or shrub along a public highway that is dangerous to the public safety once identified. Mark Hontz, Esq. then presented an overview of the amended verbiage. After a lengthy discussion, Council directed Mr. Russo to prepare an Ordinance for the next Council meeting, with one addition, the word "or designee" be added after director of public works.

OPEN TO THE PUBLIC

There was no one from the public to be heard.

COUNCIL & MANAGER COMMENTS

Mr. Ricciardo had a question regarding the forestry of dead trees at Morris Lake which was addressed by Mrs. Millikin. Mr. Ricciardo also requested that a piece of slate that is damaged in front of Town Hall be replaced.

Mayor Le Frois complimented and extended her thanks to everyone involved with the activities on Spring Street this past weekend which included the reopening of the Newton Theatre, the 9/11 Ceremony, and A Taste of Newton. Mayor Le Frois also commended the Department of Public Works for their hard work getting the benches and bike racks installed ahead of schedule to accommodate the patrons of Spring Street.

Mr. Russo announced several upcoming events which included the Arts

and Heritage Council event this Saturday and the Smithsonian exhibit which will

be on display for six weeks. Mr. Russo also announced the 175th Anniversary

event for Newton's dedicated Fire Department which will take place on

September 24, 2011 from 11:30 a.m. to 1:30 p.m. at the Newton Fire Museum.

There being no further business to be conducted, upon motion of

Mr. Ricciardo, seconded by Mrs. Becker and unanimously carried, the meeting

was adjourned at 8:03 pm.
